## **Responsive apply**

This release includes the following visible changes for BrassRing Responsive Apply in the BrassRing application.

## Apply to multiple jobs


Responsive Apply now allows candidates to apply to multiple jobs from a job search results page on responsive Talent Gateways. Candidates can now select multiple jobs on the job search results page and apply to multiple jobs simultaneously. The job search results landing page groups jobs according to their application type and whether the job has (Gateway Questionnaire) requirements. Candidates can apply to group of jobs rather than applying individually to each job.

Candidate searches for jobs and lands on the job search results page. Candidate:


- Selects **Select Jobs** and the job search results page refreshes with a selection check box next to each job.
- Selects the check boxes for jobs that candidate wants to apply to.
- Selects **Apply to job(s)**. The job grouping page opens. On the job grouping page, jobs are grouped according to their job application requirements.

• Selects **Apply to jobs** for the first job group. The Start You Application page opens and displays the jobs within that group and the approximate time to complete the job applications for group of jobs.



• Completes the job application process for that job group. The Application Complete page opens. The candidate can select **Apply to another group**, **View your status**, **Start a new search**, or **Sign Out**. If candidate selects **Apply to another group**, the job grouping page reopens and candidate can complete the job application for the remaining job group. If candidate selects **Sign Out**, the remaining job group page is saved to candidate's job cart.



#### **Responsive job cart**

The job cart is now available for Responsive Apply.

#### **Responsive Job Cart**

Candidates can now view the responsive job cart from any device. The responsive job cart also:

• Allows candidates can save multiple (or one) jobs to their job carts simultaneously. Candidate selects **Select jobs** on the job search results page, selects the check boxes next to jobs to be saved, and selects **Save**. An alert opens informing the candidate that the jobs are saved.

## Job(s) saved

• Groups jobs according to their application status (**Not Applied** or **Applied**) and allows candidates to apply to multiple jobs simultaneously. At a glance, candidates can see which jobs they applied to and which jobs require their action. Each saved job displays job titles and application or saved date.



• Removes expired jobs from candidate job carts and displays the expired jobs for the candidate.



• Alerts candidates if a new job they want to save was saved previously and contains a **View saved jobs** hyperlink.



- Allows candidates to save up to 50 jobs in their job carts.
- Displays jobs in different languages as separate jobs. For example, if one job is presented in two languages, the job cart saves the one job as two separate jobs and indicates next to each job the label of the locale. When candidates delete one of the jobs, only the one job is deleted.

Note:

Job Cart is configured by default for all Full Talent Gateways. Clients can disable the responsive job cart.



## **Responsive apply**

Several new BrassRing features are available for Responsive Apply in the BrassRing application.

#### Availability widget

The shift availability widget is now available on responsive Talent Gateways.

#### Availability Widget

Recruiters can now configure (Job Specific Questions and regular) widgets on responsive GQs with grid questions. The shift availability widget helps candidates select their availability and recruiters determine which candidates best meet their requisition requirements.

- 7. Create a responsive GQ that contains a Question widget with the following properties:
  - Question source: Talent Gateway Form (created in previous steps)
  - Question Select type Grid
  - Custom Label Availability Grid
  - Label text Instructions to Candidate
  - Inherited Select
  - Disable pre-fill response Select check box
- 8. Select Save.
